COMMENCEMENT OF PARTS OF THE PLATFORM WORKERS BILL

The Platform Workers Bill was passed in Parliament on 10 September 2024. Please refer to our October 2024 newsletter for additional work.

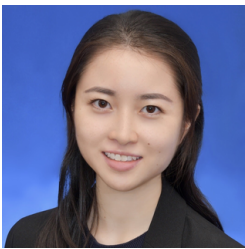
The protections for platform workers will be implemented from 1 January 2025. Ahead of this, the Ministry of Manpower will commence the following:

- Ongoing: Platform Operators can purchase Work Injury Compensation (WIC) insurance for Platform Workers
- From 1 November 2024: Platform Operators can voluntarily notify MOM of their status as a Platform Operator
- From 1 November 2024: Older Platform Workers can start to opt in to increased CPF contributions
- From 1 November 2024: Applicants can apply to register Platform Work Associations
