EXTENTION OF THE PART TIME RE-EMPLOYMENT GRANT (PTRG)

The PTRG has been extended until 31 December 2027 to encourage the continued employment of senior workers. The scheme supports employers that offer part-time re-employment, flexible work arrangements, and career planning for employees aged 60 and above. Under the scheme, employers can receive \$2,500 for each eligible senior worker, subject to a maximum payout of \$125,000 per employer.

OTHER GOVERNMENT INITIATIVES FOR SENIOR EMPLOYMENT

- (a) Employers may also benefit from the Senior Employment credit, which provides wage offsets of up to 7% for hiring workers aged 60 and over.
- (b) Mature workers (aged 40 and above) are supported through skills and career programmes such as the SkillsFuture Level-Up Programme and Workforce Singapore's Career Conversion Programme, which offers greater assistance for reskilling, upskilling, and mid-career transactions.
